Sheffield has 121\* community pharmacies providing convenient, accessible healthcare for everyone. Many offer extended hours, including evenings and weekends. Led by qualified pharmacists and skilled teams, community pharmacies provide trusted advice, medication support, and everyday healthcare close to home.

Community pharmacies are uniquely positioned to support neighbourhood-level population health goals and the ambitions of the 10-Year Health Plan. They play a key role in improving health outcomes by reducing inequalities, supporting prevention and early diagnosis, managing long-term conditions, improving medicines safety, and helping to avoid unnecessary hospital admissions.

By delivering high-quality, accessible local services, pharmacies help people stay well and receive the right care at the right time.

## Possible Future Services

Community pharmacies are ideally placed to play a greater role in local care pathway re-design with services such as:

- [Support with vaccinations](#)
- [Medication reviews](#) – Conditions could include respiratory, diabetes, hypertension, polypharmacy in the elderly.
- [Independent prescriber \(IP\) clinics](#) – From 2026 all newly qualified pharmacists will also register as independent prescribers. This will provide increased opportunities to utilise prescribers further and to provide more clinics in community pharmacy e.g. hypertension, respiratory and diabetes clinics.
- [Health screening and blood tests](#) e.g. diabetes, HIV, hepatitis B, hepatitis C, cholesterol testing, HbA1c testing
